The Rajya Sabha on Wednesday managed to take up 12 out of 15 Starred Questions for oral replies by Ministers. It happened despite an adjournment earlier during the Zero Hour.

Incidentally, this is for the second time when so many Starred Questions were taken up by the Rajya Sabha. During the last Winter Session, the Rajya Sabha took up all the listed 15 Starred Questions on January 2 this year.

Giving these figures, officials said in the Rajya Sabha, the total number of Starred Questions for oral answers listed for a day is 15. The Member in whose name a Starred question stands is allowed to ask two supplementaries. Besides, three more Members are allowed to ask one supplementary each. Generally, five to six questions are covered each day, leaving remainder questions unanswered orally, though written replies to such questions are also laid on the Table of the House.

This is for the second time when so many Starred Questions were taken up by the Rajya Sabha

The highlight of the day's proceedings in Rajya Sabha was the Question Hour which went smoothly though there were disruptions preceding it. Chairman M Venkaiah Naidu expressed happiness over the House transacting 12 questions during the Question Hour and complimented the members for the same.

**Hazare's fast enters 2nd day**

Senior activist Anna Hazare's second day on Thursday as he remained demanding his demand for appointment of anti-corruption watchdog at the Centre and in Maharashtra and resolution of farmers' issues. A bandh was also observed by locals in Hazare's native Ralegan Siddhi village in Maharashtra's Ahmednagar district in support of his demands.

Hazare is sitting on a hunger strike in his village since Wednesday against "non-fulfilment" of assurances by the Centre and the Maharashtra Government on the appointment of Lokayukt and passage of the Lokayukt Act in the State.

The 62-year-old Army man-turned-activist has also been demanding appointment of Lokayuktas in States where such statutory anti-corruption watchdogs do not exist.

He has also been demanding implementation of the Swaminathan Commission recommendations on ways to address agrarian distress, besides some electoral reforms.

Locals of Ralegan Siddhi village issued a statement on Thursday to local tehsildar, as an official representative of the state government, to look into Hazare's demands.
