The OIC reiterated its support for east Jerusalem as capital of a future Palestinian state, stressing its "Arab and Islamic character". It said peace would "only be achieved with the end of the Israeli occupation, the full withdrawal from the territory of the State of Palestine in particular, the holy city of Al-Quds Al-Sharif (Jerusalem) and the other Arab territories occupied since (the) June 1967 (Middle East war)". **AFP**

## First UN 'mercy flight' leaves Yemen's rebel-held Sanaa

Sanaa: Children in critical medical care were evacuated Monday from Yemen's rebel-held capital Sanaa, in what the United Nations hopes will be the first of many mercy flights. Seven young patients and their families have gathered at Sanaa airport, closed to commercial flights since 2016, clutching their transport documents for the trip to Amman.

"This is the first of what we hope and believe will be many flights," said UN Resident Coordinator for Yemen Lise Grande.

"It's a very important day, it's a day of hope. It shows that everyone wants the people who need help to get that help," she told reporters.

"The key is to have many flights, bigger planes, so that the people who need aid can get to the places where they

will receive it." Yemen's international-recognised government, backed by a Saudi-led military coalition, has been fighting Iran-backed Huthi rebels since 2014 when they seized control of the capital.

In November, the coalition -- which controls Yemen's airspace -- said patients needing medical care would be allowed to fly out of Sanaa.

The move was among confidence-building measures aimed at ending the five-year war that has killed thousands of people and displaced millions in what the UN has termed the world's worst humanitarian crisis.

One of the children waiting for the evacuation flight, Abdullah Abed, is suffering from kidney failure and needs an organ transplant, his father told AFP. **AFP**
