"There is a 50:50 joint venture between Air India Limited and Singapore-based SATS Limited which offers end-to-end ground handling services such as passenger baggage handling, aircraft interior cleaning and cargo handling services among others," they said. passenger was about to board a flight to Bangkok on Saturday when he was intercepted. A personal and baggage search resulted in the recovery of foreign currency equivalent to ₹42,61,920 concealed in his check-in baggage," said the senior Customs official. "During interrogation, the arrested passenger admitted to his involvement in smuggling of foreign currency in his last visit as well," the Customs officials said.
